Transfer Credit

Courses with grades of C (2.0) or better which are judged by Eastern Maine Community College to be equivalent to Eastern Maine Community College course offerings will be transferred from appropriately accredited institutions. This decision is made by the Vice President of Academic Affairs (VPAA) in consultation with the relevant academic department.

Courses of sufficient rigor, but for which the College does not offer a one-to-one corresponding course, may be transferred as satisfying free electives or general education requirements. This decision will be made by the VPAA in consultation with the relevant academic department.

In general, only courses taken within the past ten years are reviewed and considered for transfer. Exceptions may be made for courses in which the applicant's history or occupation shows continuous use and growth of the requisite skills. Exceptions will be reviewed on a case by case basis by the VPAA (or designee) and the appropriate department chair. Examinations may be required to show competency of current subject material, even for courses taken within the past ten years.

Each campus of the University of Maine System has evaluated EMCC coursework for possible transfer. In general, EMCC recognizes these equivalencies for reverse transfer as long as the student has earned a grade of C or higher in each course. TRANSFER EQUIVALENCIES FROM OTHER REGIONALLY ACCREDITED INSTITUTIONS

Students may transfer credits earned at other regionally accredited institutions for courses that are deemed equivalent to EMCC courses. Evaluation of these courses begins in the Admissions Office and may require the student to submit a copy of the course syllabi for review by an appropriate faculty member.

Prior Learning

Prior Learning Assessment (PLA) is a process by which an individual's learning from experience that is equivalent to college-level coursework is assessed and evaluated for purposes of granting credit. College-level is deemed as learning that is a level of achievement equal to subject areas traditionally taught in colleges and is commonly recognized among colleges.

PLA may be awarded in two broad categories: credit by examination and credit by assessment. A maximum of 75% of the total required credits for programs exceeding 30 credits may be earned through PLA or transfer. A maximum of 25% of the total required credits for programs consisting of 30 or fewer credits may be earned through PLA or transfer. Credit for prior learning can be awarded only after the assessment of prior learning experiences and only for documented learning that demonstrates achievement of the identified learning outcomes for a specific course or courses. Students wishing to transfer to another college or university should check with the receiving institution to determine whether PLA credit will be accepted for transfer.

In cases where nationally recognized examinations and certification are provided, EMCC will award credit by the standards generally accepted among colleges. Such examinations include:

- College Board Advanced Placement (AP)
- College Level Examination Program (CLEP)
- DSST
- International Baccalaureate (IB)
- Foreign Language Achievement Testing (CLEP, FLATs, NYU)

Where a nationally recognized exam is not offered or appropriate, EMCC <u>may</u> offer a challenge exam. These faculty-constructed exams could cover a wide variety of curricula from general education to technical courses and may be paper-or computer-based or a practical examination. The acceptable scores for awarding credit will be based on a collaborative decision of faculty experts.

ADVANCED PLACEMENT EXAM SCORES CROSSWALK

EMCC awards credit for Advanced Placement Exams to EMCC registered and matriculated students. EMCC only accepts AP Exams in certain courses in which specified scores have been earned. Official College Board transcripts must be provided to the Admissions Office.

FOREIGN LANGUAGE ACHIEVEMENT TESTING

Foreign language achievement testing can assist students in receiving credit for a broad array of languages. CLEP, Brigham Young University (BYU) and New York University (NYU) offer testing options for this purpose. CLEP offers foreign language exams in three languages: French, German, and Spanish. Credit awards are based on minimum scores. Both BYU and NYU offer exams in over 60 languages. Credits for BYU language tests are awarded based on scores from 8 through 12. No credit is awarded for scores below 8. Credit for NYU language tests will be given as follows: 3 credits for the 12 point exam and 6 credits for a 14 point exam. The results of the language exams are valid for a period of five years from the date of the exam. The [Registrar's Office/insert appropriate role/process here] will notify the student of credit awards.

CLEP AND DSST CROSSWALK

EMCC participates in the College-Level Examination Program (CLEP) and DANTES Subject Standardized Tests (DSST). EMCC registered and matriculated students can receive college credit by taking certain CLEP or DSST Examinations. EMCC only accepts CLEP/DSST Subject Examinations in certain disciplines in which specified scores have been earned. PORTFOLIO

The practice of awarding credit for college-level prior learning is based upon the belief that the education which builds on, interprets, and incorporates past and present knowledge is the education that is most meaningful to the student. At EMCC, we value the college-level knowledge students may have acquired through past work, independent reading and study, training programs or in-service courses, volunteer service or other experiences. Consequently, EMCC offers a portfolio review process by which prior learning can be analyzed, articulated, documented, and assessed for credit.

Portfolio Review is only one way for students to obtain credit based on prior learning. Prior to pursuing to the Portfolio Review option, students should consider other options available to them, including credit through national and/or department examinations (CLEP, DSST, and Challenge Exams), as well as military or proficiency credits for non-accredited training.

A portfolio in terms of prior learning is an extensive written presentation of evidence assembled by the student and reviewed by a faculty member under the direction of the Academic Affairs Office. The award of prior learning portfolio credit is dependent on relevancy to courses in the student's EMCC degree program; including general education, major and elective courses. The portfolio includes several major sections including a thorough resume, a narrative summary of relevant work and learning experiences, demonstrated skills and training in specialized areas, and applied knowledge and competencies in a specific course for which EMCC credit is available.

To be eligible for prior learning by Portfolio Review at EMCC, a student must be matriculated into a degree program, be in good academic standing, and show proof of successful completion of ENG101, College Composition.

	GENERAL PORTFOLIO REVIEW PROCESS
Step	Description
1	Student reviews EMCC catalog course descriptions to determine potential target course(s) based on student's work and/or life experiences.
2	Student meets with course Department Chair to determine whether acquired knowledge and experience appear appropriate for PLA review.
3	Student contacts Academic Affairs Office, Room 101, Maine Hall (<u>academicaffairs@emcc.edu</u>) to obtain targeted course syllabus (bi).
4	Student reviews Portfolio Development process as posted on the EMCC website.
5	Student completes the "Application for Prior Learning Credit" form and pays fee to Business Office.
6	Student prepares portfolio that reflects competencies, knowledge, and experience as related to the targeted course(s). Each portfolio will be double-spaced, typed and presented in a professional manner. The portfolio will consist of the following: Scanned completed Application for Prior Learning Credit form indicating fee is paid; Title page (1 page); Table of Contents (1 page); Resume (1-4 pages); A brief autobiography that discusses the student's career and educational history, and any other experiences that will be the basis for his/her request, and the student's academic/career goals (1-4 pages); The student's most recent EMCC transcript; The student's degree plan; For each course for which credit is requested: Current official EMCC course syllabus; A narrative which analyzes and articulates what is learned, how it was learned, how the knowledge has been used, and specifically, how this knowledge relates to learning objectives in the course syllabus (5-20 pages per course); Appropriate documentation (e.g., certificates, work samples, job descriptions, letters, awards, licenses, or any other documents appropriate to the targeted course).
7	Student electronically submits completed Portfolio to the Associate Dean of Academic Affairs in pdf format.
8	Associate Dean of Academic Affairs distributes Portfolio to appropriate faculty for assessment. Assessment will
	be completed within 30 days of submission.
9	Faculty will forward "Application for Prior Learning Credit" form to the Associate Academic Dean with recommendation. If credit is earned, student will receive a "P" on the Portfolio and appropriate credits for targeted course.
