REQUESTS FOR BIDS for Sewer Line Addition – Rangeley Hall

Eastern Maine Community College is soliciting competitive bids for the addition of a **Sewer Line to the Rangeley Hall Culinary Arts Kitchen**. This work is to be completed on a strict timeline due to a simultaneous flooring project.

Sewer Line Addition to be procured must meet the specifications below:

Scope of Work:

A new sewer line is to be installed in Rangeley Hall's Culinary Arts Kitchen. Must be tied in to the existing 3" sewer main approximately 15' from the new steam oven location;

- Concrete floor to be sawcut and soil excavated to accommodate the correct pitch. New line to be bedded with sand and plumbed into the existing 3" sewer line.
- Backfill sawcut slab slightly lower than original elevation with top layer being 4" concrete in preparation for new flooring being installed by others.
- New ½" water line to be installed w/local control valve.
- New oven drain plumbed to gravity feed into sewer output.
- Excavation to be done with electric equipment.
- The work area must be isolated with a negative air system in place.
- Remaining kitchen equipment to be covered with Poly to reduce dust contamination.
- Dispose of excavation materials off-site.

- B. D. The proposals will be evaluated and selected based on their proven ability to provide the requested service, the fees charged, and other criteria deemed appropriate by EMCC. EMCC reserves the right to reject any proposals, waive any formality in any proposal, and generally take such actions as shall be in their best interest(s).

The following must accompany your proposal: A schedule of fees and total cost for the Sewer Line Addition – Rangeley Hall.

ADDITIONAL REQUIREMENTS

- A. This RFP shall be referenced in and considered part of any final contract.
- A. The following MCCS Standard Terms and Conditions apply to all contracts with EMCC.
- B. Any MCCS entity shall have the option to purchase goods and services from the selected Vendor under the same terms and conditions outlined in this Agreement.

NOTICE TO VENDORS AND BIDDERS:

STANDARD TERMS AND CONDITIONS APPLICABLE TO ALL MCCS CONTRACTS

The following standard contracting terms and conditions are incorporated and shall become a part of any final contract that will be awarded by any college or other operating unit of the Maine Community College System (collectively "MCCS"). These terms and conditions derive from the public nature and limited resources of the MCCS. MCCS DOES NOT AGREE TO:

- 1. Provide any defense, hold harmless or indemnity;
- 2. Waive any statutory or constitutional immunity;
- 3. Apply the law of a state other than Maine;
- 4. Procure types or amounts of insurance beyond those MCCS already maintains or waive any rights of subrogation;
- 5. Add any entity as an additional insured to MCCS policies of insurance;
- 6. Pay attorneys' fees; costs, including collection costs; expenses or liquidated damages;
- 7. Promise confidentiality in a manner contrary to Maine's Freedom of Access Act;
- 8. Permit an entity to change unilaterally any term or condition once the contract is signed:
- 9. Automatic renewals for term(s) greater than month-to-month;
- 10. Limitations on MCCS' recovery of lawful damages incurred as a result of breach of the contract;

- 11. Limitation of the time under which claims can be made or actions brought arising from the contract:
- 12. Vendor's terms prevailing over MCCS' standard terms and conditions, including addenda; and
- 13. Unilateral modifications to the contract by the vendor.

BY SUBMITTING A RESPONSE TO A REQUEST FOR PROPOSAL, BID OR OTHER OFFER TO DO BUSINESS WITH MCCS, <u>YOUR ENTITY UNDERSTANDS AND AGREES THAT</u>:

- 1. The above standard terms and conditions are thereby incorporated into any agreement entered between MCCS and your entity; that such terms and condition shall control in the event of any conflict with such agreement; and that your entity will not propose or demand any contrary terms;
- 2. The above standard terms and conditions will govern the interpretation of such agreement notwithstanding the expression of any other term and/or condition to the contrary;
- 3. Your entity will not propose to any college or other operating unit of the MCCS any contractual documents of any kind that are not in at least 11-point black font on a white background and completely contained in one Word or PDF document, and that any references to terms and conditions, privacy policies or any other conditions referenced outside of the contract will not apply; and
- 4. Your entity will identify at the time of submission which, if any, portion or your submitted materials are entitled to "trade secret" exemption from disclosure under Maine's Freedom of Access Act; that failure to so identify will authorize MCCS to conclude that no portions are so exempt; and that your entity will defend, indemnify and hold harmless MCCS in any and all legal actions that seek to compel MCCS to disclose under Maine's Freedom of Access Act some or all of your submitted materials and/or contract, if any, executed between MCCS and your entity.
